Resolution CESNI 2020-II-1

European standard laying down the technical requirements for inland navigation vessels (ES-TRIN), edition 2021/1

The European Committee for drawing up Standards in the field of Inland Navigation ("CESNI"),

having regard to CESNI's Rules of Procedure, in particular article 9 paragraph 1 thereof,

adopts the European Standard laying down Technical Requirements for Inland Navigation vessels (ES TRIN) 2021/1 in the annex to this resolution,

proposes 1st January 2022 as the date for entry into force in accordance with article 10 paragraph 2 of CESNI's Rules of Procedure.

Decision of 13 October 2020

Granting of approved organisation status to the European Federation of Inland Ports (EFIP)

The European Committee for drawing up Standards in the field of Inland Navigation ("CESNI"),

having regard to the request for approval dated 7 July 2020 submitted by the European Federation of Inland Ports (hereinafter EFIP),

having regard to the CESNI's Rules of Procedure, in particular, article 2, paragraph 3(a) on the composition of the CESNI and its article 9, paragraph 3 on the CESNI's decision-making,

having regard to the CESNI's Internal Regulations concerning the status of approved non-governmental organisations, in particular their article 1 on the granting of approval,

after analysis of the compliance of EFIP's request with the criteria governing the granting of approval defined in article 1 of the CESNI's Internal Regulations concerning the status of approved non-governmental organisations,

noting that EFIP has undertaken to abide by the rules regarding approval of an organisation as stipulated in article 3 of the CESNI's Internal Regulations concerning the status of approved non-governmental organisations,

decides to grant EFIP approved non-governmental organisation status for a tacitly renewable five-year term,

invites EFIP to participate in the CESNI's future activities, especially in the field of information technologies,

instructs the Executive Secretary to notify EFIP of this decision.
