Temporary Working groups in the field of vessel technical requirements

The European Committee for drawing up Standards in the field of Inland Navigation ("CESNI"),

having regard to Article 8 of its Rules of Procedure,

having regard to its Internal Regulations on Working groups,

having regard to its Resolutions 2017-III-1, 2018-I-2 and 2020-I-1,

resolves, at the request of the permanent Working group on technical requirements for inland navigation vessels (CESNI/PT), to

- disband the temporary Working group on technical requirements for passenger vessels (CESNI/PT/Pax);
- update the mission of the temporary Working group on technical requirements for alternative fuels aboard inland navigation vessels (formerly for fuel cells) (CESNI/PT/FC), as defined in <u>Annex 1;</u>
- update the mission of the temporary Working group for electronic equipment and systems on board of inland navigation vessels (CESNI/PT/ELEC) as defined in <u>Annex 2</u>;
- set up the temporary Working group on the transitional provisions of the vessel technical requirements (CESNI/PT/DT) as defined in <u>Annex 3</u>;
- set up the temporary Working group on the new model of vessel certificate (CESNI/PT/MOD) as defined in <u>Annex 4</u>.

This Resolution shall enter into force immediately.

Annex 1 to Resolution CESNI-2021-II-1

Mission of the temporary Working group on technical requirements for alternative fuels aboard inland navigation vessels (CESNI/PT/FC)

1. Mission

The CESNI work programme 2022-2024 envisages the following task: "To draft requirements for the use of alternative fuels on inland navigation vessels" (PT-1).

The objective is to ensure the safety and ease of navigation by inland navigation vessels using alternative fuels as the vessel's propulsion systems or onboard power supply.

To this end, the CESNI/PT/FC temporary Working group has been tasked with preparing draft technical requirements for the use of alternative fuels aboard inland navigation vessels, including the bunkering, storage, distribution and processing of suitable primary fuels. The mission does not include developing requirements for vessel operation or crew training.

The CESNI/PT/FC temporary Working group shall follow the priorities set out in the work programme: 1) storage of methanol, 2) storage of hydrogen (liquified and gaseous), 3) methanol in internal combustion engines, 4) storage and use of compressed natural gas, 5) other alternative fuels.

In discharging its mission, the CESNI/PT/FC temporary Working group will build on a preliminary draft of the technical requirements prepared by the delegations (in particular Germany, Belgium and France), but also on the experience gained in the various countries with pilot projects for vessels.

The CESNI/PT/FC temporary Working group shall carry out its mission under the supervision of the CESNI/PT permanent Working group.

2. Composition

12 meetings of no more than one day's duration are planned for 2022-2024.

The CESNI work programme 2022-2024 envisages the following task: "To review and simplify the transitional provisions for existing vessels, with the support of a temporary working group" (PT-7).

The objective is to prepare the revision of the transitional provisions laid down in Chapters 32 and 33 of ES-TRIN, as well as the associated regulatory frameworks, in view to simplify the application of ES-TRIN to existing vessels (for instance presentation of all transitional provisions in a single table).

In the light of the preparatory work carried out by the Belgian delegation (CESNI/PT (20) 34) and by a Group of volunteers (CESNI/PT (21) 14 rev. 1), the Working Group CESNI/PT should finalise a list of principles to guide such revision of the transitional provisions.

To this end, the CESNI/PT/DT temporary Working group has been tasked with preparing draft amendment of Chapters 32 and 33 of ES-TRIN as well as to assess the impact of these amendments.

Mission of the temporary Working group for Electronic Chart Display and Information System for Inland Navigation (CESNI/TI/Inland ECDIS)

1. Mission

The principal missions of the **temporary Working group for Electronic Chart Display and Information System for Inland Navigation** (CESNI/TI/Inland ECDIS) shall be:

- to prepare proposals for the revision of the ES-RIS on the parts concerning Electronic Chart Display and Information Systems for Inland Navigation (including the operational and performance requirements, test methods and required results) as referred in CESNI's multi-annual work programme for 2022-2024;
- to provide advice regarding the proper implementation of the standards in the field of River Information Services (RIS) in particular regarding Inland ECDIS or for other tasks in the work programme and relevant to the group's expertise;
- to provide advice and analysis on standards in the field of RIS in particular regarding Inland ECDIS or for other tasks in the work programme and relevant to the group's expertise;

The temporary Working group CESNI/TI/Inland ECDIS shall carry out its mission under the supervision of the permanent Working group on information technologies (CESNI/TI) and cooperates with the groups Inland Electronic Navigational Charts Harmonization Group (IEHG) and the International Hydrographic Organization (IHO).

2. Composition

The temporary Working group CESNI/TI/Inland ECDIS shall be composed by experts with a high level of expertise related to RIS and especially in the field of Inland ECDIS, designated by the Members of CESNI referred to in Article 2 paragraphs, 1, 2 and 3 letter a, b, and c of the Rules of Procedure of the CESNI.

Individual experts referred to in Article 2 paragraph 3 letter d of the Rules of Procedure of the CESNI shall make themselves known to the Secretariat should they wish to participate in the work of the temporary Working group CESNI/TI/Inland ECDIS.

As a matter of principle the members of the temporary Working group CESNI/TI/Inland ECDIS created by resolution 2019-II-6 are renewed as members of the temporary Working group CESNI/TI/Inland ECDIS that is the subject of this resolution.

The Secretariat shall thereafter be kept duly informed of any change regarding the composition of the temporary Working group CESNI/TI/Inland ECDIS.

3. Scheduling of work

The temporary Working group CESNI/TI/Inland ECDIS shall start to work according to its mission described under paragraph 1, as from 1 January 2022, and shall complete its work at the latest upon expiry of the CESNI work programme at the end of 2024.

4. Number and frequency of meetings

11 meetings lasting no more than half a day are planned for 2022 to 2024.

The temporary Working group CESNI/TI/Inland ECDIS will decide on a meeting schedule at its first meeting following the entry into force of this resolution in coordination with CESNI/TI and the other temporary working groups.

The number and frequency of meetings shall only be increased upon agreement of the CCNR Secretariat, in consultation with CESNI and in accordance with the multi-year financial agreement between the CCNR and the European Commission as referred to by Article 2, paragraph 4 of the Internal Regulations on working groups.

- 32. ESI-III-2 (concerns only the Dutch version).
- 33. ESI-III-8(1), (2) title and introductory sentence are worded as follows:

"1. General

Recreational craft of up to 24 metres length, that are placed on the market, have to comply with the requirements of Directive 2013/53/EU. According to Article 3 in conjunction with Article 2 of this Directive, recreational craft having a length of 20 metres or more shall carry an inland navigation vessel certificate attesting the craft's compliance with the technical requirements of this Standard. Since double inspection or certification for certain equipment, arrangements and installations of newly built recreational craft which can result from certain provisions in Article 26.01 of Standard should be avoided, this Instruction gives information on those requirements listed in Article 26.01 that are already sufficiently covered under Directive 2013/53/EU.

2. Requirements in Article 26.01 which are already covered under Directive 2013/53/EU

For recreational craft subject to Directive 2013/53/EU the inspection body shall as regards to the issuance of the inland navigation vessel certificate (initial inspection) not require further inspection or certification of the following requirements of Article 26.01(2), provided that the craft presented for inspection has been placed on the market no more than 3 years before the date of presentation to the inspection body and no modifications to the craft have been carried out, and the Declaration of Conformity refers to the following harmonised Standards or their equivalence:".
