having regard to the CESNI’s Rules of Procedure, in particular, article 2, paragraph 3(a) on the composition of the CESNI and its article 9, paragraph 3 on the CESNI’s decision-making,

having regard to the CESNI’s Internal Regulations on the status of approved non-governmental organisations (“Internal Regulations”), in particular their article 1 on the granting of approval,

after analysis of the compliance of CEN’s request with the criteria governing the granting of approval defined in article 1 of the Internal Regulations,

noting that CEN has undertaken to abide by the rules regarding approval of an organisation as stipulated in article 3 of the Internal Regulations,

decides to grant CEN approved non-governmental organisation status for a tacitly renewable five-year term,

which will take effect on the date of the last signature of the Memorandum of Understanding between CCNR, CEN and CENELEC,

starting from that date, invites CEN to participate in CESNI’s future activities,

having regard to the CESNI's Internal Regulations on the status of approved non-governmental organisations ("Internal Regulations"), in particular their article 1 on the granting of approval,

after analysis of the compliance of CENELEC's request with the criteria governing the granting of approval defined in article 1 of the Internal Regulations,

noting that CENELEC has undertaken to abide by the rules regarding approval of an organisation as stipulated in article 3 of the Internal Regulations,
